**ORDER**

As per the Government Order read above, Kerala Rubber Limited (KRL) was formed to function as the dedicated state level agency to promote manufacturing of natural rubber (NR) and rubber wood based products in the State. One of the major schemes implemented at the national level for enhancing productivity and competitiveness of Micro and Small Enterprises (MSEs) and their clusters is "Micro and Small Enterprise - Cluster Development Programme (MSE- CDP)". Under the MSE-CDP, Government of India grants can be availed for establishing Common Facility Centers (CFCs) and infrastructure development for the benefit of MSE sector. Currently, the Directorate of Industries and Commerce is the state level agency for implementing the scheme. The Chairperson and Managing Director, Kerala Rubber Ltd (KRL) informed vide letter read as 2<sup>nd</sup> paper above that it would be appropriate to designate KRL as the Implementing Agency for MSE-CDP in rubber and rubberwood sectors.

The Director of Industries and Commerce vide letter read as 3<sup>rd</sup> paper above has reported that, since KRL has adequate sectoral knowledge and domain expertise in Rubber Sector, they can be engaged as Project Management Consultant (PMCs) or State Level Implementing Agency for the development of Rubber / Rubber Wood based CFCs being approved for the State under the MSE-CDP Scheme of Ministry of MSME, Government of India.

Government have examined the matter in detail and are pleased to designate Kerala Rubber Ltd (KRL) as State Level Implementing Agency for the development of Rubber / Rubber Wood based CFCs.
