## **ORDER**

As per G.O read as 2 <sup>nd</sup> above,the Board of Directors of Kerala Rubber Ltd. was reconstituted with Smt.Sheela Thomas IAS (Rtd) as Chairperson & Managing Director and she took charge on 09.09.2021. Vide G.O read as 3<sup>rd</sup> above, Government have fixed consolidated pay of Chairperson & Managing Director of Kerala Rubber Ltd as Rs. 2,00,000/- (Rs. Two lakh) per month.

Through the letter read as 1 st above, the CMD, Kerala Rubber Ltd has informed that the terms and conditions of appointment of CMD was not mentioned in the G.O read as 3<sup>rd</sup> above. Smt. Sheela Thomas retired as Additional Chief Secretary to Government of Kerala. As per the details shared from various government organizations Smt. Sheela Thomas is eligible for various allowances.

As per the letter read as 1 st above it is informed that the matter was placed before the Board of Directors of Kerala Rubber Ltd held on 01.09.2022 and the Board has recommended the suggestion to request the Government in fixing the

terms and conditions of appointment of the CMD, Kerala Rubber Ltd. Hence Chairperson and Managing Director, Kerala Rubber Ltd has requested Government to issue orders to fix the terms and conditions of the CMD including tenure.

Government examined the matter in detail and agrees to the proposal for fixing the terms and conditions of appointment of CMD, Kerala Rubber Ltd. Tenure of appointment of CMD is fixed as three years from the date of joining. Smt. Sheela Thomas, CMD, Kerala Rubber Ltd is eligible for the following.

1)Reimbursement of expenses related to shifting of her house from Thiruvananthapuram to Velloor and also for shifting back to her permanent residence at the end of her tenure.

- 2)Residential accommodation (rent upto Rs. 20,000/- per month) to be provided by Kerala Rubber Ltd.
- 3)Reimbursement of travelling allowances as per the rules of Government of Kerala.
- 4) Vehicle facility during her tenure in the company.
- 5). Medical facilities as per the rules of Government of Kerala.
- 6) Reimbursement of expenditure for mobile phone and Internet connection.
- 7) 15 days earned leave per year during her tenure in the company.
