ORDER

As per the Government Order read above, sanction was accorded to entrust Kerala Bureau of Industrial Promotion (K-Bip) as the implementing agency, with processing of rubber related applications during the Financial Year 2024-25 or till KRL develops necessary resources to take up the activities for the development of Rubber/Rubber Wood based CFC's and KRL is entrusted with implementation of infrastructure development works for t h e i r Integrated Rubber Complex at Velloor, Vaikom Taluk, Kottayam District.

2) As per the letter read as second paper above, the Chairperson & Managing Director, Kerala Rubber Ltd has informed that KRL is in the process of setting

up Integrated Rubber Complex and related infrastructure facilities at Velloor, Kottayam. For availing grant under “Micro and Small Enterprises- Cluster Development Programme (MSE-CDP), KRL needs to be designated as the State Level Implementing Agency for the project under MSE-CDP. Hence the CMD, KRL requested to modify the Government order read above as “However, KRL is entrusted with implementation of infrastructure development works for their Integrated Rubber Complex at Velloor, Vaikom Taluk Kottayam District under MSE- CDP.”

3) The Director of Industries and commerce vide letter read(3) above has reported that KRL has taken steps to improve infrastructure and man power deployment and there has been significant efforts to improve the resources and capacity of KRL.
