ORDER

The Chairperson and Managing Director, Kerala Rubber Limited vide letter read as first paper above has furnished a proposal for the scheme "Development of an integrated facility and industrial complex for promoting natural rubber based and ancillary industries' under Kerala Rubber Limited for the consideration and approval of the Departmental Working Group. Government has included Rs. 900 Lakh, under the H/A 4860-60- 190-90 to Kerala Rubber Ltd in the budget for the FY 2025-26.

2)The objectives of the scheme are as follows

- Ensure better price realization for rubber growers
- Facilitate value addition of NR
- Develop world class manufacturing infrastructure to promote investment in the rubber sector
- Ensure seamless linkages for procurement of NR from rubber growers
- Establish processing facilities for NR and undertake trading activities to create demand
- Operate in Public Private Partnership mode;
- Ensure better returns to stakeholders:
- Generate employment by creating direct as well as indirect job

opportunities etc.

3) The expected outcome is as follows

- Improve marketability and value addition of natural rubber and thereby increase returns to growers with focus on Rubber Producers Societies (RPS) and other farmer groups
- Establishment of natural rubber based manufacturing industries in Kerala to supply high quality rubber products destined for domestic and international markets and make the State a hub for rubber based industries.
- Providing quality infrastructure for setting up natural rubber based industries.
- Development of rubber-based industries with specific thrust to technology oriented and value-added non-tyre rubber products.
- Improve generation of employment opportunities for economic advancement of rural people.
- The implementation of the project is proposed to be scheduled and completed in two phases from 2022-23 to 2026-27.
